## OVERVIEW

The property is ideal for drive through retail concepts, a supermarket, or a convenience store. The property also offers a prime opportunity to leverage the Live Local Act (SB102) and max out residential unit count.

The property is located in West Little River. Little River is an up and coming neighborhood that is starting to see a major boom. The western portion of the neighborhood is relatively untapped, giving an investor or developer a strong strategic advantage to pick up a large piece before the area heats up. The property is 10 minutes from the bay as well as the heart of the Miami Urban Core.
