The property is fully fenced and features a crushed gravel lot. It is currently leased on a month-to-month basis to two tenants, providing a new owner with significant flexibility—whether for owner-user purposes or as an income-producing investment.

The property also includes a revenue-generating billboard, providing the owner with additional income. Additionally, a cell tower is situated on-site, occupying approximately 900 square feet without interfering with tenant operations.

The property is located on the corner of Dyer Blvd and Barbour Rd in Riviera Beach FL. Just five minutes from the I-95 exit on Blue Heron Blvd. Providing close proximity to major roadways and highways. This strategic location and ease of access plays a pivotal role in the historical high demand at this location.
